**Please Note:** Nominees do not need to be a member of the emerging leaders committee or subcommittee to be included. The group's definition is here for reference purposes only: The Emerging Leaders subcommittee is a group of professionals interested in the advancement in the affordable housing and community development industry. This group is designed to examine and promote the way in which we attract new professionals and those seeking professional advancement, how we encourage their participation and mentor their growth, how to connect them with networking opportunities that shows our encouragement of their development and provides a platform to showcase their strengths.

When reviewing the nominees for the *Rising Star Award*, please review the Nomination Form and consider what information was asked for, taking the following into consideration in the following order:

- First, the nominee's participation at the NCRC level whether on the board, on a NCRC committee or subcommittee, as a trainer, etc. Second, the nominee's participation at the National NAHRO level whether on the board, on a National committee or subcommittee, as a trainer, etc.
- Third, the nominee's participation at their State Chapter whether on the board, on a committee or subcommittee, as a trainer, etc.
- Fourth, the nominee's participation at their local PHA level and within their local community detailing their level of involvement and accomplishments.

Please score each nominee with a score between 1 and 25 with 25 being the highest score a nominee can get. Participation at the NCRC level is valued up to 9 points, National NAHRO is valued up to 7 points, State is valued up to 5 points, the local PHA and community participation is valued up to 3 points and 1 point for additional comments or support. Email your scores directly to the committee chair and do not reply all so that information collected is not based on another person's scoring decisions.
