We were also joined by variety of HUD Regional staff. From the classroom to special events, the conference hit it out of the ballpark. Thank you to the Conference Planning Committee for their hard work and dedication to making it a complete success!

One of the roots of NAHRO is advocacy. I believe it is OUR job as housing professionals to advocate for our programs and the families we serve. NCRC published its first Legislative Position Paper. A BIG thank you to Jim Dewey and his Work Group for their contributions—this is a significant accomplishment. Members were able to use this paper with their Hill visits in DC.

We also launched our “Advocacy for the Busy Professional” at the Iowa Conference in April. Jim Inglis and I presented at the NCRC Conference and the goal is to present in all 8 states over the biennium. Our hope is that we would have members in each state become a part of a Speakers Bureau to continue the work in their state.

We continue to keep tabs on the administration’s proposals for funding and reform. The 2018 Omnibus Bill felt like a win with programs saved, however there was still a loss on the Administrative Fees for the Housing Choice Voucher program. We

are having conversations nationally on how to better describe and advocate for these fees—how do we tell our story about the necessity of the admin fess? Small Agency Reform continues to be on our radar and Senator Crapo (R-Idaho) is sponsoring S.2155. While this bill does exclude some small agencies by definition, it would still be a win and a starting point for small agency reform.

NCRC celebrated its 70th anniversary while in Indiana. We hosted a beautiful party at the President’s Dinner and it was wonderful to celebrate with our members. As an industry we have so much to be proud of. We have worked tirelessly to move our agencies forward. We continue to think innovatively and create partnerships in our communities. We work to find opportunities to help our families thrive and succeed. We have done all of this during times when the funding for our programs have been at staggering all-time lows. WE have persevered. Congratulations to all of you. This 70 years is a celebration of all of us!

Housing Committee

Rick Moore, Vice President of Housing



As most have heard by now, Congressional Leaders and the White House reached an agreement on a Final FY18 Omnibus Appropriations Bill. Funding was increased on nearly every major HUD program and the housing tax credit program was increased as well. The housing credit

will get a 12.5 percent increase in allocations for four years, CDBG will receive \$3.3 billion, HOME will receive \$1.3 billion, and Housing Choice Vouchers will have an increase of \$1.7 billion just to name a few. In addition, the authorized ceiling for public housing units converted under RAD Component 1 increased from 225,000 units to 455,000 units. This will allow HUD to draw more projects from the RAD conversion waiting list.

A conference call of the NAHRO Housing Committee was conducted on March 14, 2018. Agenda items discussed included an update on the budget process and review of new suggestions for policy changes to be given to appropria-

tors. Members discussed a policy provision allowing for PHAs to project-base vouchers to their own properties without creating a subsidiary or affiliated non-profit with which to execute a HAP contract, as well as a policy provision requiring HUD to update their HCV Guidebook not less frequently than once a year. Other ideas of short legislative changes were also mentioned by committee members.

NAHRO National Committee on Housing discussed several topics including;

- Executive Order Reducing Poverty in America by promoting opportunity and economic mobility;
- Updating HUD Handbooks;
- Voucher Administrative Fee;
- Triennial Recertifications

I will continue to send updates as they become available.

It was great to see many of you at the NCRC Conference in Fort Wayne, Indiana on April 29th through May 2nd.

I am presently working on a 294-unit multi-family housing proposal to be built over the next five years in three phases.

The developers of the proposal are requesting Tax Increment Financing (TIF) over a 26-year period. By receiving this Housing TIF, 118 units will be rented at affordable housing rates. The City has no other risk or funding in the proposal.

Is this a sure thing? Well, no, its not. Anyone who has worked in a political process knows that nothing is a sure thing.

And, while housing is a national/international concern, sometimes what it comes down to is that it starts in the community we live in. Why is it we think we can solve housing problems somewhere far away when we have difficulty solving them in our own backyard? All housing issues are local.

So, I would propose that I should exchange ideas with others not to correct their housing problems but rather to help me correct my own. Perhaps they have a great idea that worked and by my attending a conference or work session, I can bring it home. Perhaps I can share something that worked for us, and they can bring it home. I like this approach better than thinking I have the answer to their housing issues. The old saw of being an expert in something is when you are 20 miles from home can still ring true but also hollow.

I attended the Canadian Housing and Renewal Association Annual Meeting on April 24 right after the National NAHRO Spring DC conference. I listened in a number of sessions and said a few words at the International Symposium but I want to share an idea that I heard regarding the dignity of housing people.

That idea is not necessarily new but I heard a lot about "Housing is a Human Right" in Ottawa. Once we agree that Housing is a Human Right, we place a priority in our legislative processes to make sure our population is housed and that means all of our

population.

When Housing is a Human Right, we have a legal obligation to house our homeless people rather rely on charity organizations to do the heavy lifting of housing people. This made sense to me.

I am following up right now with some of the speakers I heard in Ottawa and aim to invite them to present in the USA regarding the Housing is Human Right. We are thinking that the Annual NCRC meeting in Nebraska in 2019 may be a good setting for these speakers. Keep this is on your agenda.

Thank you for the opportunity to represent the NCRC in another country and bring home a good idea.

Professional Development Committee

Sharon Carlson, Vice President of Professional Development

As a Standing Committee in the NAHRO Organization, the Professional Development Committee exists at the national, regional and state chapter levels. The national NAHRO PD Committee is primarily organized in three subcommittees, identified as 1) Curriculum; 2) Quality Assurance; and 3) Marketing. The three subcommittees work to assess the content and quality of NAHRO trainings and to provide training opportunities to members.

Currently, NAHRO has 58 offerings in various formats, from live to online opportunities. The curriculum subcommittee is working with NAHRO to regularly review and complete updates for outdated courses, work with NAHRO trainers, and solicit feedback from members on new courses that are needed. All trainings and trainers are reviewed by the Quality Assurance subcommittee, which provides feedback to the curriculum subcommittee and to trainers. The Marketing subcommittee works with NAHRO program staff to provide the highest-quality training opportunity while continuing to explore the most cost-effective way to reach members.

The NCRC PD Committee should have at least one member from each state in the region, devoted to helping with organizing conference session offerings during the regional conference and to provide feedback to the national committee. The PD Committee is currently working with Nebraska for the regional conference scheduled for Omaha in April, 2019.

Based on need and at the request of members, NAHRO continues to expand its partnerships with Professional Development organizations with areas of expertise that already have established, high-quality programs. In addition to training specific to Community Development, Low-Income Housing Tax Credits, and Sustainability and Growth, NAHRO offers program content specific to the Rental Assistance Demonstration PBV program, and will soon offer RAD PBRA. NAHRO has four training centers in the NCRC

region. Thus far for 2018, Livonia will host HQS training 5/21 – 5/23, HCVOEIR 8/13 – 8/17, and Managing Maintenance

10/15 – 10/17. Cincinnati will host Property Management Essentials 6/19 – 6/21 and UPCS 9/17 – 9/17. <https://nahro.personifycloud.com/PersonifyEbusiness/Default.aspx?TabID=1355&>

will provide information about these offerings as well as any that may be scheduled for the centers in Columbus and Hammond. John L. Carroll Memorial Scholarship for Small Agencies

The Spring Application period closed April 16, 2018 at 5 p.m. E.T. During the national committee meeting held April 21, 2018 in Washington, D.C. four scholarships of the ten possible were awarded (only four applications were received!). Three of these scholarships were to Michigan agencies, with the remaining one to a Washington agency. The next application and award period will be open in the fall, and all agencies with up to 550 combined Public Housing and HCV units are encouraged to apply. At the Legislative Conference in Washington, D.C., The Members Services Committee had a very productive meeting.

The Member Services Committee discussed the current membership numbers had dropped slightly since the last conference. It was also mentioned that dues totals had

remained steady thanks in part to the Newark, NJ Housing Authority re-joining.

This year we also received a higher number of Awards of Merit applications (210). The committee is hopeful that this trend continues. Of the applications (193) will receive a Merit Award and (60) have been nominated for the Awards of Excellence. The Awards Subcommittee discussed some changes to fees and who could apply for the Awards. They would like to keep the early bird and regular rates. The subcommittee discussed the increase in late fee \$150 and maybe opening up the awards to non-members. If it was agreed the application fee would be much higher at \$250. Discussion was also

had about the Awards of Excellence presentation needed to be more prominent. It was suggested that it be moved from the last plenary session at the National Conference to the second plenary session.

The Marketing and Relationships Subcommittee discussed ways to obtain and retain current members. It was suggested that a welcome committee should be formed at every level (state, regional, & national). Other things discussed were offering a 1 time reduced registration rate to non-members for a conference. Also a mapping program so the subcommittee can see where members are located so they can match them to a non-member in the area and encourage them to join.

The IT Subcommittee reported that they are reviewing the online Journal and the timeline for the website redesign. A survey about the website will be coming out soon and encourages everyone to complete it once it is available. Discussions are being had about renewal being sent and paid online and also Associate changes being made and reflecting changes in real time.

The Emerging Leaders Subcommittee had a meeting about mentorship that was attended by 9 Fellows. This mentorship would be help new and Emerging Leaders develop into leaders. Other things discussed were topics for the Brown Bag Session. The Subcommittee will be submitting a proposal for the National Conference that will include the Fellows.

The Member Services Committee (Task Force) will continue to review the Summer Conference to if it is still viable.

conference. If you don't have your Certification for Commissioners, plan to enroll in the class. There is a lot of valuable information whether you have been a Commissioner for a while or newly appointed.

At the January work day prior to the board meeting, each work group set goals for the next two years of President Keogh's term.

Goals that were set by the work group were as follows:

- Recruit new members
- Identify new Executive Director's within one year of their employment
- Reach out to 3 housing agency's to show relevance of NCRC and its' membership
- Identify small HA's of 250 or less and 499 or less
- Work with Legislative Committee
- Website Forum

Legislative Report Jim Dewey, NCRC Legislative Chair



Since the submission of the previous quarterly Legislative Committee report, the legislative landscape has remained as robust as ever. I thought about titling this report "Live from DC it's Anyone's Guess". Congress finally enacted a 2018 budget

through an Omnibus bill that was approved in March 23, 2018. This bill contains a 10 percent increase in spending for the Department of Housing and Urban Development (HUD). This means that nearly every single program in the HUD portfolio received additional funding. But, as of this week, the President would like to rescind \$41 Million dollars allocated to Capital Fund. National has been providing e-blasts

on the latest updates. Keep an eye out for these and take the time to review and understand how it may affect your programs.

Secretary Ben Carson testified in front of the House Appropriations T-HUD subcommittee on March 20, 2018 to answer questions concerning HUD's FY 2019 budget proposal. Several programs within HUD's portfolio are proposed to be drastically decreased or eliminated under the President's budget proposal, including CDBG and HOME. Highlights of the testimony included replacing key benefits of the CDBG with Opportunity Zones, an emphasis on RAD conversions, and the merging of Capital Funds and Operating Funds (though steep budgetary cuts are proposed to the Operating Fund). Highlights of the President's proposed 2019 budget are below:

Legislative Committee Report Continued....

- **Public Housing Capital Fund:** \$0, a \$1.941 billion decrease
- **Public Housing Operating Fund:** \$2.477 billion, a 44 percent or \$1.6 billion decrease
 - Operating Fund includes an additional \$364 million in additional funds for set-asides that were previously funded through the Capital Fund, such as Jobs Plus. The budget lists top-line funding as \$2.8 billion.
- **Rental Assistance Demonstration:** \$100 million, a \$100 million increase
 - The budget proposes an expansion of the RAD program and eliminates both the cap and September 30, 2020 deadline for submission of applications.
- **Choice Neighborhoods:** \$0, a \$137.5 million decrease
- **Section 8 Housing Assistance Payment Renewals:** \$17.514 billion, a 4.6 percent or \$841 million decrease
- **Ongoing Administrative Fees:** \$1.53 billion, a 6.7 percent or \$110 million decrease
- **Family Self-Sufficiency:** \$75 million, level funding
- **Section 8 Project-Based Rental Assistance:** \$10.866 billion, a \$50 million increase
- **Community Development Block Grant:** \$0, a \$3 billion decrease
- **HOME Investment Partnerships:** \$0, a \$950 million decrease
- **Housing Opportunity for Persons with AIDS:** \$330 million, a 7 percent or \$26 million decrease
- **Homeless Assistance Grants:** \$2.383 billion, level funding

I am proud to say that 112 NCRC members went to Washington DC last month for the Legislative Conference to advocate for our programs. I think that is a huge number representing our region. During that conference the Legislative Leadership Committee met and established this year's NAHRO Advocacy Plan. This plan will focus on maintaining 2019 funding levels, expansion of MTW, regulatory reform, preparing for the incoming 116th Congress, building some grass roots advocacy by strengthening our Congressional District Contacts (CDC's), improving regional communication, bringing in business partners, State housing alliances and coalitions.

A new Public Housing Caucus has been formed by Senator Cleavers and Senator Stivers. I understand that there have been about a dozen other's that have since signed up to this caucus. This is huge for our industry and advocacy efforts. I think this will strengthen our budgetary position with congress for many years to come. Please inform your legislators about this caucus and encourage them to join as well.

National also set a goal for advocacy letters for this August and for the year of 3,000 and 5,000 respectively. I challenge the NCRC membership to be the region providing the most letters in 2018!

Our NCRC Legislative Task force completed our region's Legislative Position Paper that was released to our members and sent on to National on April 6, 2018. I would like to thank all task force members, Branna Lindell, Steven Rackis, Barbary Dacy and Alan Zais, for their work on this paper and helping our region express some of our issues and concerns about the programs we administer to help the most needy in the communities.

Community Revitalization & Development Report (CR&D)

Judith Carlin, Vice President of CR&D

The Omnibus and Appropriations Bill provided housing and transit a historic win. Housing tax credits will increase 12.5% over 4 years. The income formula for what counts as affordable housing was adjusted; the result of the change will enable higher income families to qualify for affordable housing. The intended result is to have higher income tenants to offset low income renters. Programs the President's budget targeted for elimination survived; HOME Investment Partnerships Program and the Community Development Block Grants were provided a bump in funding. The bill also expanded RAD to include Section 202 Housing for the Elderly communities.

National CR& D goals and objectives for 2017-2019 are: discuss, review, and analyze housing, revitalization, and development issues through legislative, administrative, and judicial lens; improve Communication and Outreach; and act as a Program and Operations Expert Resource. 2017-2019 NAHRO Goals and Objectives, 1/12/2018. CR&D will work through task force groups to develop assignments and determine outcomes.

For PHAs interested in pursuing RAD, it is expected that the RAD cap increase will, at historic application levels, provide 12 months of opportunity for PHAs. Balancing the decision to move forward with an application is HUD's discussion of providing PHA's a path to voluntary conversion of public housing to a Section 8 platform.

Following up on the current status of Opportunity Zones, it is reported that all states participated. On April 8th Treasury announced the first round of approvals. As of April 15th the following NCRC states were approved: Michigan, Nebraska, and Ohio. The CDIF is assisting Treasury through the nomination and designation process only. Further guidance from Treasury on Opportunity Zones is forthcoming.

On May 17th the Joint Economic Committee held a hearing on "The Promise of Opportunity Zones." Testimony was heard from Senators Corey Booker and Tim Scott as well as from industry representatives from Enterprise Community Partners, Economic Innovation Group (EIG), and Local Initiatives Support Corporation (LISC). Speakers focused on the potential dollars of investment which will be available to communities in need, however, they urged Treasury and Congress to clarify language and insure transparency and accountability of Opportunity Fund activities, and prevent abuse. Terri Ludwig of Enterprise Community Partners highlighted the potential for abuse resulting in the net elimination of affordable housing.

2018 Community Development Award of Excellence



Congratulations Dakota County Community Development Agency, Keystone Crossing Workforce Housing Townhomes

Keystone Crossing is the newest townhome development in the Dakota County Community Development Agency's Workforce Housing Program. Dakota County is the third largest county in Minnesota, and the Dakota County Community Development Agency (CDA) has identified a need for affordable housing for working families, especially in the core cities of the county that have large employment centers. The CDA often coordinates with cities to redevelop blighted or under utilized areas and further the mission of providing affordable workforce housing for families earning modest incomes. The CDA created the Workforce Housing Program in 1990 as a way to develop rental housing in support of working families with children. The primary goal of the Workforce Housing Program is to lower the

monthly housing costs of low and moderate income working families and provide an opportunity to live in the communities where they work, attend school, shop, access services and other amenities. Since that time, the workforce housing portfolio has grown to 25 developments with 807 units. There is great demand for affordable workforce housing in Dakota County. Families are facing other factors such as low vacancy rates, increasing average rents and job growth in employment sectors that pay a modest wage. Residents are able to become self-sufficient by living in affordable housing and saving for a down payment on a home, transportation, child care or pay off debt. The CDA's Workforce Housing Program is innovative as it created a 20-year partnership with US Bancorp Community Development Corporation to finance the acquisition and construction of additional units of affordable housing in a community of high demand. The CDA is the managing partner who maintains and manages the operations of the housing development. At the end of the 20 years, the development has fulfilled its requirements of the partnership and it is turned over to the CDA as the full owner of the property. This partnership allows the CDA to continue to identify needs and increase capacity of the organization to provide units of affordable housing in Dakota County. While other agencies may have similar programs, the level of affordability that the CDA achieves makes this an affordable solution that attains its goals of lowering the monthly cost of housing for working families.

2018 Housing Award of Excellence



Congratulations City of Lincoln, Reading Matters

PHAs across the country have been challenged to participate in addressing the critical issue of literacy and grade-level reading. Lincoln Housing Authority (LHA) responded to that challenge by developing the Reading Matters program. Reading Matters is promoting literacy and boosting educational outcomes by presenting new, diverse, age-appropriate books to children 12 and younger, whose families reside in LHA's low income housing programs and gently used books to all families involved with LHA. Along with the distribution of books, education is also provided to families regarding the importance of Reading Aloud 15 minutes each day. Reading Matters was developed in recognition of some startling national statistics which we believe are also representative of low income households in Lincoln, Nebraska.

"Nationwide, 61% of low income families have no books at all in their homes for their children (Children's Literacy Foundation)." "These children are six times more likely to leave school without a diploma if they are unable to read proficiently by the end of third grade (Barbra Bush Foundation for Family Literacy)." "An alarming number of children – more than 80 percent of those from low income families – are not proficient readers by the end of 3rd grade. This has significant and long-term consequences not only for each of those children but for their communities, and for our nation as a whole (The Campaign for Grade-Level Reading). "More than four out of five children from low-income families are not hitting the benchmark of reading well by the end of third grade. The personal and social costs are staggering, affecting success in school, work, and life. There is a growing consensus that grade-level reading should be a shared national goal (Research from gradelevelreading.net)." The Reading Matters program objective is to give low-income children in Lincoln a foundation for success by incorporating books into housing assistance and encouraging families

to read aloud together. Distribution of New Books: New, diverse, age appropriate books are purchased to distribute to children 12 and younger, who reside in one of LHA's low income housing programs. At least once a year each child receives a new book to take home. The book is selected by the parent or the child. Distribution of Used Books: Gently used books, donated by employees, local businesses, and the community are made available to all families at the LHA central office, the maintenance office, family resource center, and all leasing offices and club houses. Children and families are welcome to browse and take a books home. These are available for children to keep and they can always come back to get more books. Promotion of Reading and Read Aloud 15: Information is given to every family to encourage them to "Read Aloud 15" by either listening as children read books aloud or reading aloud to children for 15 minutes each day. Extra books are also given as an incentive. A local restaurant donated 250 bookmarks each month for a year. Once a child reads and records seven books on the bookmark, they can return the bookmark to the restaurant for a free kid's meal. While literacy programs are not a new idea, we believe the Reading Matters program is a unique and innovative program for the children and families of LHA. The program motivates and encourages reading through distribution of new and used books, offering incentives for reading on a regular basis and on-going education regarding the importance of reading and reading out loud. The program has received strong support from residents, employees and the community and has established partnerships that will continue to assist with the sustainability of the program. It is a simple program that just makes sense and those who support it financially know that 100% of their money goes to high quality books at low cost and no donations or grants are used for administrative overhead.

2018 Alvira B. Long Memorial Award



Congratulations Dina Getty, Winnebago County Housing Authority

Ms. Getty's community leadership has been demonstrated in such areas as creating a Therapy Dog program that she brought to several of the housing authority sites. Ms. Getty created the Little Library program for a number of the Winnebago county Housing Authority sites which she secured funding through the Winnebago county Board. Ms. Getty has appeared alongside WCHA staff at neighborhood meetings and with to explain the reason and process for the mixed finance programs of WCHA. As a board member, Ms. Getty was responsible for supporting and approving \$33 million in mixed finance programs for the new construction and rehabilitation of 316 units of affordable housing in five cities for LIHTC, competitive ARRA, CFFP and RAD-II. She also approved WCHA's administration of a neighboring housing authority's 167-unit RAD-I program when it was requested by HUD to save the mixed finance program for that agency. Ms. Getty was instrumental in helping create the NAHRO Commissioner certification program and "The Handbook for Commissioners" through her work with in the National NAHRO Commissioner's Committee. Ms. Getty helped to create and was a panelist in a National NAHRO conference session designed to help troubled housing authority boards recover. Ms. Getty a member of the National Commissioners Committee was instrumental in helping create the NAHRO Commissioner certification program and "The Handbook for Commissioners" through her work with in the National NAHRO Commissioner's Committee.

2018 Legislative Advocacy:

Minnesota NAHRO has a strong legislative committee that has been conducting conference calls every Friday during the legislative session. Our calls typically involve at least a dozen members and we are working on the following key initiatives:

- Leading an effort to secure \$30 million in General Obligation Bonds for Public Housing Rehabilitation.
- Leading the effort to secure \$110 million in Housing Infrastructure Bond funding for the development of affordable housing, including "senior housing" as a new eligible use.
- Tracking a consensus proposal and providing testimony to ensure we do not lose bonding set-aside for single family housing.
- Supporting two new initiatives: a state Tax Credit Contribution Fund and the allocation of funds to a Housing Trust Fund.

On February 28th we hosted Minnesota NAHRO Day at the Capitol. The day began with an orientation to provide our members with tools, training, and talking points for their day with scheduled visits to legislators. The event was very successful with over 35 visits made to legislators.

Organization and Other:

On March 1st, MN NAHRO conducted a Board Strategic Planning session followed by our business meeting. Using a PowerPoint presentation, I provided our board with a general organizational overview. This overview included MN NAHRO's relationship

with NCRC and national NAHRO. We also reviewed our mission statement, core values, board member expectations, and our membership.

During our strategic planning, we broke into work groups according to some broad focus categories and developed priorities for the coming two years. From this planning, a 2018-2019 work plan will be drafted for board review and approval at our next board meeting.

One of our regular business items was a review the membership drive results for 2018. We again offered our flat rate for commissioners which has significantly increased commissioner membership. As a member benefit, we also provide each commissioner member a complimentary copy of our MN NAHRO Commissioner Handbook that was completed last year.

At the request of NCRC, I have appointed a MN representative to both the Small Agency Task Force and the Conference Committee.

MN NAHRO is leading a work group consisting of member agencies who developed Transitional Housing in the 1990's financed with a 20-year forgivable loan provided by Minnesota Housing Finance Agency (MHFA). Due to GO Bond legislation and regulation, HRAs have been informed that an additional 15-year compliance period will be required. We have over 400 units of housing in the state financed with this program. The work group has developed a position paper and entered into conversations with MHFA staff to ensure the ongoing viability of these properties throughout the state.

Upcoming Events:

Our MN NAHRO spring conference will be held at Madden's Resort near Brainerd, May 23rd – 25th, 2018. The conference has seven (7) different tracks of learning opportunities including a national training to assist members with updating their HCV Administrative Plan.

Plans are now underway for our summer Leadership Retreat that will be held July 19th and 20th in Worthington.

OHIO CHAPTER

The 2018 OHAC Annual Spring Conference was held April 11th – 13th at the Kalahari Resort and Conference Center in Sandusky, OH. The training included Hearing Officer, Property Management essentials, UPCS/REAC Updates, EPIC/Capital Fund, Mental Health and Legislative Updates. We also added a training for Directors and Board Members; *Strategic Leadership*. This session included discussions on enabling legislation, defining roles and responsibilities of the staff and board members, ethics, conflict of interests, strategic planning, and coaching for board member performance. The highlight of the Spring Conference was the six

\$1,000 scholarships we gave away.

We have scheduled two trainings one in both the spring and summer. The first, we will be partnering with Ohio Capital Corporation for Housing to offer a Blended Occupancy Management – LIHTC training on May 29th – 31st in Akron, OH. Then June 25th – 29th we will have a Public Housing Management training (with certification) also in Akron.

We have our 2018 OHAC Annual Fall Conference scheduled for September 19th – 21st in Columbus. We will begin the planning in the near future.

Late last year we spoke out in opposition of Ohio HB 282 which would potentially recognize residential rental property damages as criminal mischief. It went on to prohibit a metropolitan housing authority from renting or providing housing assistance to a person who has recently been convicted of criminal mischief relating to residential rental property. Earlier this year the Financial Institutions, Housing and Urban Development Committee for the State of Ohio amended the bill to address our concerns. We are continuing to follow this bill in committee.

Each month the local HUD field office hosts a teleconference call with all housing authorities. Hot topics, policy, procedure, and funding are regularly discussed. During the April call, attendees were able to hear from the new field office director, Shirley Wong.
